Earlier today I took the time to send in further comments regarding the Mid-Halton Master Plan to which I expected the Region to answer my comments

on an individual basis; not as a block comment in some report. If there

has been a change in the Region's policy since this process started then $\ensuremath{\mathsf{T}}$

expect you to inform me accordingly; in the mean time I expect to receive a

reply back an individual response to my questions from the region notwithstanding Mr. Ohashi's comments.

In line with your statement "And of course, we are accountable to you, the

Halton community!"; I would draw you to the position that it could be considered that Halton Region's approach [together with the Town of Oakville

(OPA198)] are directly working against the present residents best interests.

It makes no economic sense to have growth that defiles the community and

that such growth is not at least 100% totally fully self financing. While $\,$

the results of a lack of growth would lead to a retention of undeveloped

areas on the one hand, on the other hand it would also lead to house shortages and a corresponding increase in prices. Interesting concept.

The expansion of the Mid-Halton Sewerage Plant will do nothing for the residents of the area in question, except apparently increase our taxes to

fund growth and increase the potential for unwanted odour as well as increasing the potential of more pollution on the beaches in the area.

In my opinion, what is needed is a moratorium on all future expansion growth

until all aspects associated with such continued growth are fully understood. It appears that our elected representatives have allowed

the Regional Staff to get us on a growth merry-go round that is out of control and apparently is not in the best benefits of the present area residents that our elected representatives should be working for. An interesting concept -- that elected representatives should owe no allegiance

to possible future residents that do not reside here now.

In closing I would point out that the "privileged" statement added by the

region at the bottom of their reply email in no way applies to my submission

--- I have no objection to everyone in the Halton Region, the Town of Oakville, knowing my comments. It is unfortunate that the Region consider

that such a statement is considered necessary to be inserted to communications in these circumstances. I presumed that this is to be

I look forward to receiving an individual response to my questions as related to my submission below for the Mid-Halton Master Plan.

I would add that while I am part of the tax-base for the region and the town, nevertheless when it comes to anything else I feel totally disenfranchised; and that is just not acceptable.

> Just like the slide presentation at the meeting on 5th February 2003
> present a slide of the plant as currently, present a slide of the
> expansion up to 75,000 m3/day.

166,000
> m3/day as that would not serve the region purpose, nor to portray the
> intended impression.
> Regional staff have stated that expansion of the Mid-Halton plant is
> most cost effective way, when to stay expansion and future growth is
> most cost effective way for the present tax-base based upon the

> However the most damaging situation that I heard was that regional

- > previously carried on the regional website but appears to have been > removed.
- > (3) Layouts that show the Mid-Halton site layout for the 166,000 m3/day
- > capacity, based on present understandings.

- > (4) Provide a complete copy of the Odour study parameters to be covered
- > as part of the next Odour study.
- > (5) Provide a complete schedule timetable applicable to the next Odour
- > study and when such study is intended to be started. (This should be
- > started now and cover summer months).
- > (6) Provide the regional staff's detailed written procedure for when
- > residents register complaints, including odour complaints.
- > (7) Conclusive backup data that supports the region's position that their
- > proposed expansions (plural) will not adversely affect the environment
- > including Lake Ontario (algae growth --- phosphorous implications).
- > (8) That continued expansion in the region will the 100% (or better)
- > totally covered by development levies. Including costs associated with
- > any upgrades in technology as required due the increase in scale by
- > continued such increased growth.
- > (9) That the present increases in expansion up to 75,000 m3/day as
- > required by presently "sold-forward development" will be totally covered
- > by development levies associated by such requirements.
- > (10) What is the region's intended corrective action, if any, to provide
- > "barrier protection" to the golf courses abutting the Mid-Halton Sewerage
- > Plant.
- > (11) What is the region's intended action, if any, to increase the
- > "barrier protection" to the local residents.
- > (12) What proposals the region intends for review applicable to placing
- а
- > moratorium on all future expansion growth until all aspects associated
- > with such continued growth are fully understood.
- > (13) A copy of all other submissions made to the region and the reply > responses issued.
- >
- > I have also copied this email to Allan Elgar (Local and Regional
- > Councillor Ward 4 Oakville) and others.
- > In closing I would add that a visit to the region's website home page
 > includes an opening address by a statement from the Regional
 Chairperson.
- > This statement ends with "And of course, we are accountable to you, the
- > Halton community!". I feel certain that when all the facts are known
- > by the people, including that we are paying in part for future growth and
- > that such growth is already causing environmental problems with the
- > corresponding lowering of our surrounding environment. I believe that
- > they will not be pleased, I for one am defiantly not pleased.
