Dear Minister,

As you are aware from our discussions, the Town of Oakville is currently undertaking a study of the lands in the vicinity of QEW/Bronte Road. This area includes land that is currently owned by the Province and leased to the Deerfield Golf Course through Infrastructure Ontario (IO).

As part of the study, the town has held a number of community consultations to discuss alternative land uses. I have attended these meetings and met regularly with residents in the area. I know there is strong public support for the continued use of the land as a golf course and I am writing to request that any plans to sell the property are cancelled. I would agree however that some development potential exists along the North Service Road/QEW frontage.

The Deerfield Golf Course has a very active membership and a large pay-as-you-play clientele who are committed to the future of the golf course. In addition, Deerfield is next to the sensitive lands included in the natural heritage system of the 14 mile creek.

Over the years the Town of Oakville has become one of the most co-operative supporters of Ontario's Greenbelt introduced by our government.
