130. The portion identified as Deferral No. 10 on Map 1, "The Regional Structure"; and
131. The portion identified as Deferral No. 6 on Map 1, "The Regional Structure", and outlined in green on the attached Map 1A subject to the following modification:

- a) The lands outlined in red on the attached Map 1A, are hereby redesignated from "Greenlands B" to "Urban Area".

As thus modified these further portions of the Official Plan or the Regional Municipality of Halton, are hereby approved pursuant to Sections 17, and 21 of the Planning Act, R.S.O., 1990.
